The road was an important part of the Roman road network in Scotland, enhanced by the placement of camps and signal stations along it. As a continuation of the roman road

							which was one of the main routeways between Hadrian's Wall and the Antonine Wall, it derives much of its cultural significance from the other scheduled and unscheduled portions of the road. The nearest ancillary Roman asset is Little Clyde, camp (SM2745), located immediately adjacent to the eastern end of the monument. Another Roman road runs on the opposite side of the River Clyde to the southwest (WoSAS ID 12129). Elements of its setting from which it derives its cultural significance are its relationships with the routeway along the Roman road and its visibility with other Roman assets which are located to the east of the asset. Due to modern development, the road cannot be easily distinguished and thus appreciated in its current setting. Up to 9 turbine tips of the proposed Development are predicted to be visible at various points along the road, in general views to the south. The proposed Development would not be visible or anticipated to impact views towards along the Roman road running east to west or to and from other Roman assets. As such, the proposed Development is not anticipated to cause significant adverse effects on the ability to appreciate, understand, or experience the asset

Up to 3 turbine tips of the proposed Development are predicted to be visible in general views to the south. The proposed Development would be visible in background of views towards the valley below. Elements of setting from which the asset derives its significance from is its relationship to the River Clyde and valley to the east, northeast, and southeast, and the Roman

In general, burial monuments are often found in proximity to watercourses or located in conspicuous locations. In this case, the cairns are located directly adjacent to Air Cleuch, which drains to the River Clyde c. 650m to the east. The area of cairns are located on a southeast facing slope which overlooks the River Clyde and the valley below. Crookedstane, platform settlement (SM4646) may have been contemporary and is c. 300m to the south on the same contour. Elements of its setting from which it derives its cultural significance are its position near the watercourse and views

Defensive Iron age forts, such as this, were often placed on conspicuous locations to grant views over specific routeways and associated features in the landscape, in order to monitor and defend. The fort is located overlooking the River Clyde approximately 600m to the south and east and at the junction of two river valleys. Its position gives the fort expansive views along these two valleys which would

Elements of its setting from which it derives its cultural significance are its position at the convergence of these two river valleys, its views along the watercourses, and the contemporary assets at the base of the hill to the southeast. Up to 9 turbine tips of the proposed Development are predicted to be visible in general views to the southeast. Three of the turbines would likely be visible in the hills to the east of the River Clyde valley which is a main contributor to its cultural significance. These would likely be a minor distraction to a single aspect of its setting and would not cause significance adverse effects on the ability to appreciate, understand, or experience the asset within its setting. Its position was likely deliberate to be easily defensible and also provide access to fresh water for its inhabitants. The fort also lies directly on the path of a Roman which was a main routeway between Hadrian's Wall and Antonine's Wall. There is a linear spatial relationship along the course of this routeway, comprised of other small fortlets and signal stations, the nearest being a Nap Hill Signal Station (SM102) approximately 550m to the southeast along the route of the road. Elements of its setting from which it derives its cultural significance are its relationships with the routeway along the roman road and its visibility with other signal stations and Roman assets which are located to the southeast of the asset. Up to 3 turbine tips of the proposed Development are predicted to be visible from the asset in general views to the southwest. The proposed Development would not be visible or anticipated to impact views along the Roman road or to and from the signal station. As such, the proposed

The asset is now within forestry and no visibility of the camp is possible. Elements of its setting from which it derives its cultural significance are its relationships with the routeway along the roman road to the northwest and southeast and its visibility with the roman camp to the northwest.

Settlements, such as this, are commonly located

Other assets which may be associated exist on the northern side of Elvan Water and include other house platforms (WoSAS ID 13324) c. 80m to the west and a burial cairn (WoSAS ID 57692) c. 250m to the southeast. The two areas are set at the opening of a river valley, where the Elvan Water joins the River Clyde c. 1km to the east. This location grants both settlements expansive views out the mouth of the valley to the east in addition to the views along the Elvan Water to the west. These positions would have granted these settlements a vantage from which to overlook movement along the valley and seem deliberate. Elements of its setting from which it derives its cultural significance are its relationships with the routeway along the Roman road and its visibility with other Roman assets which are located adjacent to the road to the east and northeast. Due to modern development, the road cannot be easily distinguished and thus appreciated in its current setting. Up to 8 turbine tips of the proposed Development are predicted to be visible at various points along the road, in general views to the southwest and west. Where the road
